

EDITORIAL REQUIREMENTS

Article construction:

- Title of article (bold, capital letters, centered),
- Authors: full names and surnames (centered),
- Affiliation: Department/Team, Faculty, Institution, City (centered). City should only be provided if it is not included in the name of the unit.
- Corresponding author's email (centered),
- Abstract (approx. 200 words),
- Keywords (3-5 words),
- Introduction,
- Materials and methods,
- Results and discussion,
- Summary,
- Acknowledgments,
- Literature.

Text

- Text file in *.doc format (Word 95 or newer).
- Font: 12-point Times New Roman, bold and italics are permitted, no underlining.
- Line spacing: 1.5.
- Left margin: 3 cm, other margins: 2.5 cm.
- Text should be justified.
- Please avoid leaving empty lines, word division, or any special formatting.
- **The article should not exceed 15-20 pages.**
- Please ensure uniformity in abbreviations used throughout the article. Provide explanations and expansions for abbreviations upon their first usage in the article, e.g.:
 - PBS (phosphate-buffered saline).
- SI units (International System of Units) should be used in the work.

Illustrations and Tables

- Figures must have good quality, uniform format, and descriptions.
- Each illustration should be provided as a separate file.
- Photographs: *.tif, *.jpg, or *.psd files with a resolution of at least 300 dpi; lower-quality files can only be reproduced in small sizes.

- Tables must be embedded in the text at the target location (not at the end).
- Each table and figure should be numbered and have a caption (font size 11 pts, centered):
- Table title should be placed above the table, e.g. ‘Table 1. Xxx’
- Figure caption should be placed below the figure, e.g. ‘Fig.1. Xxx’
- Abbreviations style for tables and figures in the text: (tab. 1), (fig. 1).
- Do not include illustrations, diagrams, or drawings from the Internet.

Literature

- Bibliographic descriptions should be presented consistently.
- When citing literature, use square brackets, e.g.: [1]; [1-3]; [2, 5, 7].
- Square brackets should be placed before the dot at the end of a sentence.
- Do NOT use footnotes. Include the literature at the end of the article in the order cited in the text.
- Please use abbreviated journal names with dots.
